### MA AGO Division of Public Charities and IRS NEW Online Filing

Attorney Machiko Sano Hewitt recently participated in the Massachusetts Attorney General's pilot program for the new MA Division of Public Charities online filing portal; testing it out and providing feedback. She would like to let you know about changes the new portal will bring for Initial Charity Registrations and Form PC filings, as well as recent changes involving IRS 990N filings.

#### **New IRS Platform for Form 990N**

Beginning August 1, 2022, smaller charities that are eligible and choose to file <u>Form 990-N</u>, Electronic Notice for Tax-Exempt Organizations (e-Postcard), must sign into the IRS modernized authentication platform. See details here:

#### IMPORTANT TIME SENSITIVE UPDATES TO MA PFML



Important updates to the Massachusetts Paid Family and Medical Leave law ("MA PFML") are going into effect on January 1, 2023. The Department of Family and Medical Leave ("DFML") has revised contribution rates and benefit amounts. **Employers are required to communicate these changes to employees as of December 2, 2022.**
